




## Club Reciprocal Agreement

between

### The Brisbane Golf Club Inc. & Takamatsu Gold Country Club

1. The intent of the Agreement is to permit Club Members in good standing at both Clubs to have an opportunity to be introduced to other overseas clubs, who may then extend certain privileges, subject to the respective host Club's local rules, regulations and dress code, policies and this agreement.
2. Letters of Introduction from the Secretary/General Manager must be sent in advance. Use of email is preferred for these letters. Proof of membership as well as a Letter of Introduction will be requested on arrival at the host club.
3. Any facilities are at the sole discretion of the host club, unless otherwise agreed. Members are to pay for purchases to simplify International Exchange, unless the Club requires signing privileges be used.
4. Visiting Members are not required to play with or be accompanied by a member of the host club.
5. A visiting member shall be entitled to pay up to six rounds per calendar year at a reciprocal club. Tee times must be made through the Secretary/General Manager at each club.
6. A visiting member may not introduce guests at the host reciprocal club without the expressed advance permission of the Secretary/General Manager. Guests, if allowed will be charged the daily green fee rate of the host club unless otherwise agreed.
7. All members with playing rights at either Reciprocal Club shall have full playing rights at the other Reciprocal Club. **Green fees will not be payable for reciprocal members, however any additional taxes & charges associated with green fee charges will be payable.**
8. No joining rights are granted to Members of either Club under this agreement and nothing in these rights shall be construed as giving any Member preference in joining either Club except in accordance with the terms and conditions of entry and membership as prescribed in the Constitution, By-laws and Rules of each Club and payment of fees determined by each Club from time to time.
9. Member of either Reciprocal Club are admitted to the other Club under the general terms and conditions prescribed in the Constitution, By-laws and Rules or other authoritative instructions of the Reciprocal Club. Any expenses incurred during the visit must be paid for immediately.
10. Either club may cancel the Agreement by providing 60 days' written notice.
11. Subject to such qualifications, restrictions and limitations contained herein, the following reciprocal rights for the specified categories of members are hereby arranged and agreed between **The Brisbane Golf Club Inc and Takamatsu Gold Country Club.**
12. We, the undersigned, being persons properly authorised to commit The Brisbane Golf Club Inc and Takamatsu Gold Country Club to reciprocal arrangements, do hereby declare that this agreement shall come into force until amended as may be mutually agreed between the Clubs or cancelled by either Club on giving six (6) months' notice in writing to the other Club.
