

RECIPROCAL CLUB AGREEMENT



The Western Australian Golf Club Inc

of 60 Hayes Avenue, Yokine, Western Australia and

The Brisbane Golf Club Inc of 70 Tennyson, Memorial Avenue, Yeerongpilly, Queensland

enter in to this Reciprocal Club Agreement whereby:

- Each of the undersigned Clubs shall extend to any visiting Member of the other Club all the privileges
 to the Golf Course and other Club facilities given to its own Members in the category of membership
 which is closest to the rights and privileges to which the visiting Member is entitled at their own club.
 Absentee, Non Playing, Introductory and Overseas members are not permitted to use Reciprocal
 Rights.
- 2. The above mentioned privileges will be exclusive of the regular fee usually charged to visitors and for a maximum of twelve (12) days in any calendar year. Any additional rounds above this limit will be charged the standard Member Guest rate.
- 3. Reciprocal Club Members must produce evidence of current membership upon arrival. It is also preferable that a letter be forwarded by the Reciprocal Club in advance advising of the impending visit.
- 4. Reciprocal Club Members shall be subject to all Rules, By-laws and other controls in effect at the time of their visit and all purchases for meals, drinks, etc must be paid for in cash or by credit/debit card.
- 5. Each Reciprocal Club Member shall have the same rights to introduce guests as a Member of the host Club (subject to course availability) and such guest shall pay the normal green fee applicable to a guest playing with a Member and adhere to the host Club's guest policy.
- 6. A Reciprocal Club Member shall be eligible to take part in all minor Club Competitions provided they possess a valid Golf Link number and pay the prevailing competition fee. They are not eligible to participate in Honour Board or Perpetual Trophy events unless prior permission has been granted by the host Captain.
- 7. A Member of Brisbane Golf Club residing temporarily for more than one continuous month or on a permanent basis in Perth is not entitled to Reciprocal privileges beyond the first month of residency. Similarly, a member of The Western Australian Golf Club residing temporarily for more than one continuous month or on a permanent basis in Brisbane is not entitled to Reciprocal privileges beyond one month of residency.
- 8. This Agreement shall remain in force until such time as either Club upon written notice terminates it giving three months' notice.
