

## Reciprocal Agreement between Southport Golf Club and The Brisbane Golf Club

We, the undersigned Clubs, hereby enter into an agreement whereby:

- Each of the undersigned Clubs shall extend to any reciprocal member of the other Club all the
  privileges to the golf course and other club facilities usually given to its own members in the
  category of membership, which is closest to the rights and privileges to which the reciprocal
  member is entitled at his/her own Club.
- 2. Reciprocal members shall abide by the booking procedure advised by the host club.
- 3. Reciprocal members must upon arrival produce an introductory letter and identification. It is preferable that a letter of introduction is sent to the vising club prior to arrival.
- 4. A Reciprocal member exercising visiting playing rights at a host club may do so on not more than three (3) occasions in any calendar year.
- 5. Reciprocal members shall be subject to all rules, by laws and other controls in effect at the host Club at the time of their visit.
- 6. Except in the case where the Club concerned charges its members a daily green fee in addition to their subscriptions, no visitor's fee or green fee shall be charged to the reciprocal member.
- 7. Subject to course availability and prior approval by the General Manager of the host club, a visiting member shall have the same rights to introduce guests as are applicable to a member of the host club. Such guests shall pay the current member introduced visitor green fees.
- 8. Any purchases made by a reciprocal member at the host club must be settled, either by cash or credit card, on the day of the visit.
- 9. A reciprocal member **shall be eligible** to take part in all minor Club competitions. A minor Club competition is a competition other than a major Club competition.
- 10. A reciprocal member **shall be ineligible** to take part in major Club competitions or perpetual trophy events. Major Club competitions include Honour Board events and Monthly Medals.
- 11. A reciprocal member may take part in a Club fourball event in the company of a member of the Home Club, or with an invited guest as a partner. Each player must possess an accredited Golf Australia handicap.
- 12. Bookings from reciprocal clubs are restricted to a maximum of eight (8) players on any one day. Groups larger than eight (8) players will be treated as 'group booking' subject to approval by the General Manager and each player will be required to pay a green fee equivalent to the member introduced rate at the time.

- 13. A reciprocal member may apply to the reciprocal Club to become a member of that Club.
- 14. The Committee of each Club shall consider any such application on its merits and without obligation.
- 15. If at the time of application to the reciprocal Club pursuant to this agreement, there is no vacancy in the relevant category, the applicant shall receive priority over other applicants for membership to that category. Pending admission to membership, the reciprocal Club shall grant playing rights on such conditions and subject to such fees, as the Committee of the reciprocal Club may from time to time determine ("interim rights"). The granting of interim rights to an applicant for membership will not affect the Committee's discretion under the preceding paragraph.
- 16. A person elected to membership by a reciprocal Club under the terms of this agreement must pay, in addition to the pro rata subscription, the prescribed full entrance fee applicable to that Club.

17. This agreement shall remai	in force until such	time as it is termina	ited by either Club	, upon one
month's written notice.
